Registration, Evaluation, Authorization and restriction of CHemicals

MCG companies in Europe are well aware of the EC regulation 1907/2006 (REACH) and its requirements and timetables. Therefore MCG is fully committed to meet its obligations under REACH and thus safeguard the continuation of supply of its products. REACH is a pre-condition for MCG to do business in Europe.

MCG is a producer of polymer mixtures (compounds) and thus acts mainly as a Downstream User (DU) for most of the ingredients. In case MCG is the Importer into the EU its duties are covered by an Only Representative (OR).

However, we will keep paying attention to possible changes in our REACH status to ensure that we have the ability to maintain our best quality services and provide you with the products you need. Therefore, we work in close cooperation with our raw materials suppliers.

Since the publication of the first list of substances (SVHC) late October 2008, we continuously check if we may use such substances in our plants also by involving our suppliers, and we ensure a close monitoring of the candidate list updates.

If our mixtures contain one or more Substances of Very High Concern, we are required to disclose such information, if the concentration of these substances is higher than 0.1% w/w in the delivered products. The objective is to ensure communication within the supply chain, and allow you to meet your own obligations under the REACH Regulation.

Safety Data Sheet (SDS) according to REACH Annex II

MCG SDSs are edited according to European Regulation CLP (1272/2008), effective since 1st June 2015 for the mixtures.

These SDSs are updated in the following cases:

- Modifications of Annexes XIV, XVII and the SVHC list
- Modification of the classification

The current version is valid until further modification.

Labelling according to CLP regulation

The **CLP** regulation (EC N°1272/2008 – **C**lassification, **L**abelling, **P**ackaging for hazardous substances and mixtures) is the European variation of the **GHS** (**G**lobally **H**armonized **S**ystem of Classification and Labelling of Chemicals).

MCG products are labelled according to the CLP regulation when shipped in Europe and according to GHS when shipped outside Europe.

Substances of Very High Concern (SVHC) candidates for annex XIV

Last Update: 4th February 2026

Article 33 of the REACH regulation, requires: " Any supplier of an article containing a substance meeting the criteria in Article 57 and identified in accordance with Article 59(1) in a concentration above 0,1 % weight by weight (w/w) shall provide the recipient of the article with sufficient information, available to the supplier, to allow safe use of the article including, as a minimum, the name of that substance."

The following list indicates the SVHC substances that can be intentionally added to the delivered compounds:

Section 15 of the Safety Data Sheet will provide you with information about the presence of SVHC substances above 0.1%. Please note that communication on the absence of SVHC in preparation is not mandatory.

This document is no longer valid in case of modifications in the candidate list.

Please consider that MCG products are mixtures in pellet, powder or filament form. Therefore, they do not need to be notified in ECHA's SCIP (substances of concern in products) database. Companies supplying articles containing SVHCs on the Candidate List in a concentration above 0.1% weight by weight (w/w) on the EU market have to submit information on these articles to ECHA's SCIP database, as from January, the 5th of 2021.
